Section 1: 4th bullet point:assist principal in programmatic and operational Changes; (POTENTIAL IMPACT OF BUDGET, make us aware once we know for sure what to expect, OUR input. Affect on Course catalog. CREATING an accurate realistic catalog)

Anna Lisa: Ms.Crandall reviews catalogs annually and edits it. Makes it accurate as possible before opening it to guidance office and course selection. There are many variables that make this difficult. AP vs Non-AP classes (AP psychology and Non-AP psychology for example) Non college prep classes such as business courses. It needs to be balanced and available to all students with varying needs.

Mrs. Gannon: Her goal is to all students have a four year plan of study such as a Humanities academy, STEM academy, Health Sciences academy.

Sherlet:requesting as part of our responsibilities on SGC is to informed about academy creation and our opinion included.

<u>Section 2</u>: provide advice on any other policy matters affecting school (Graduation/ discussion on INDIVIDUALITY)

Mrs. Gannon: approached by senior requesting that seniors be permitted to decorate graduation caps. States that she asked other principals, 50% permit and 50% do not permit. She invited senior to be present at meeting tonight. (*Invited student did not attend meeting) As of last year students now allowed to pick the color of hat, yellow vs. green. In past color was designated by gender.

Anna Lisa and Chris: concerns about how to check on appropriateness of cap design. Not enough time and enough faculty to check prior to graduation ceremony. also if found to be inappropriate, potential parent discontent when student is on stage without cap.

Ava: Would like to see caps decorated but after listening to potential problems outlined is not totally committed to having caps decorated.

Corrine: Submit design like Chalkfest? Set guidelines for appropriate decorations? Mrs Gannon states it would be impossible to get all 400 designs reviewed and approved. Plus make sure design matches the cap on graduation day.

Amita:supports teachers regarding inability to make sure cap designs are appropriate

Sherlet: Suggested parental permission slip; Brought up that signatures can be forged and most students will forget to submit permission slip on time.

Erica: still have risk of student decorating cap with inappropriate statements after graduation and posting on social media.

Christy: Keep the caps as is without decorations. Less risk of controversy

Council suggested that student requesting should provide more information to Mrs. Gannon. Also whatever decision Mrs. Gannon makes, **we will support her 100%.**
