The Superintendent read the four recommendations that the Board was considering to recommend for approval.

The first was to revise the green and gold guide starting with school year 2022-2023 so that all PE courses taken from this point forward are not calculated towards weighted GPA.

The second was to continue with the current plan as articulated in the green and gold guide for all PE classes to not be leveled nor calculated towards the weighted GPA, beginning with the Class of 2026, current ninth graders.

The third was to retroactively recalculate the weighted GPAs of all current Hamden High Students by removing weight from PE courses already taken allowing students to retain their current GPA if recalculation would lower GPA.

The fourth option was to revise the process of PE classes not count towards GPA beginning with the 2022-2023 school year for all students with the sole purpose of college applications and not for the purpose of determining class rank report either weighted or not-weighted PE to colleges or other post-High School institutions, depending on which of the two is in the student's best interest.

5. Move to approve the revising of the green and gold guide starting with school year 2022-2023 so that all PE classes taken from this point forward are not calculated towards weighted GPA.
