Hello. My name is Bethany Potenziani. I am a mother of 3 and a lifelong resident of the town of Hamden. I currently have a 9 year old who is in 4<sup>th</sup> grade at Ridge Hill, a Pop Warner cheerleader and a Hamden youth lacrosse player. She has been superintendent student of the month as a kindergartener and has been awarded student of the month for her class 7 times in less than 5 full years as a Hamden public school student. Throughout her entire school career, she has always been above the average in reading and math, even with a full year of distance learning. I am fortunate and thankful that while a lot of students had a difficult transition from in person to distance, she was able to work hard to keep herself motivated and keep herself ahead of the pace. I am writing this email to you all on her behalf, because if I do not stand up for what I believe is right for my child, what sort of parent am I?

Earlier this month, as to be expected, word of the possibility of our children being able to return to school unmasked circulated through my daughters class. To see the light in her eyes and the smile on her face was disheartening. At the time, we were one of the very few towns left in the state with a town wide mask mandate still in place, so I knew the idea of unmasking children in school, when we were unable to grocery shop as unmasked adults, was a very unrealistic expectation. I explained to her as well as possible that this was the case, and that we should plan to continue to wear masks, but to also be optimistic for a change. Fast forwarding to just last week, when news broke of Mayor Garrett lifting the mask mandate, and seeing the positive Covid percentage in our town to be as low as it is, I began to think that what I first thought to be a long shot, became much more of a reality. Then watching as Board of Ed's throughout the state began voting to send their students back unmasked, my hopes were about as high as they could get, only to watch Monday night as they all came crashing down.

I am sending this email to all of you, the town elected board of education members, in hopes of you sitting back and thinking to yourself that the decision you made Monday is unjustified, as well as harmful to our children's emotional and mental well being. We are just one week away from the two year anniversary of the day that our childrens 'normal' came to a screeching and to them, very confusing halt. Little did they know, the morning of Thursday March 12<sup>th</sup>, 2020 would be the last morning for far too long that they would have a normal day of school. Little did they know, it would be the last day they would be able to see their friends and teachers faces and reactions, eat lunch next to their best friends, and to walk freely through their school, their safe space. Now looking back on it, we as adults also did not know that the "two week flattening of the curve" would now turn into two years of the most daunting and confusing time of our lives.

We have been told to hold on a little bit longer far too many times. To wait for Halloween to pass, then Thanksgiving, then the holidays, then the cold season. To now hear "what will spring break bring" and "were in the orange" and the "vaccination numbers are too low". With all due respect, what more can you expect from our children? The town is in the orange, meaning we have 10-14 cases per 100,000. In a town with less a population far less than 100,000, what more are you asking for? When do you all as parents and humans step back and think that it is time to allow parents to make decisions for their own children and families? To trust that parents have enough common sense to do what is best. To know that if numbers start rising, that parents will do what is right for themselves and others. Why can you not allow people the freedoms we have been denied for two years?

Thank you for your service to Hamden. I believe you have a very difficult job and have been put between the proverbial rock and hard place when it comes to making decisions that will please everyone. Hello again,

I write to you again in hopes that you will seriously reconsider last week's mask mandate decision.

I understand that at the time of that vote, maybe you did not have all the latest information and guidance from the CDC and other public health officials that may have made everyone more comfortable in joining the 85% of other school districts who voted to go mask optional. I understand that, at your core, you are likely trying to accommodate the comfort level of our most worried parents and teachers.

I am hoping, that now, with a week to consider all that has happened since last Monday, you will give yourselves the grace and permission to change your mind. Changing your mind does not mean you were wrong to start, it simply means you are considering new information. The best leaders know how important this is. . I think it is difficult to realize something you vehemently believed in and adhered to for 2 years may never have done much good, and holding on to it seems like the best way to keep it true, but it's time for people to accept the new truths about Covid. Science is not a religion. It is not something to be believed without question forever. It is something that is continually changing – we have to be able to accept these changes – even if when it means changing course on policy we really believed in at one time.

The public health officials are mostly in agreement at this time that the benefits of masking children are minimal at best and zero at worst. Again, I won't quote the stats, the studies, the negative impacts of continued masking. I know you have access to all of these.

I know that at the other end of this argument are scared parents and teachers. I try to empathize with parents and teachers who have been traumatized for the past two years and are not ready to emerge from Covid cocoons yet. My goal is not to rip their masks away. If they need these security blankets a bit longer for themselves, that is fine. But your goal, as the board of education, should **not** be to make policy based on comfort levels. Your policies should be based on fact and logic. When the facts and logic tell us that masks are hurting us more than they are helping us, then we can no longer wait until the most scared among us is ready to unmask. I would even argue that you are doing people a disservice by enabling irrational fears, by continuing mandates that are no longer based on fact. Panic policy which may have been justifiable in 2020 is not rational policy for 2022.

Aren't we under a moral obligation to model sane and rational thinking for our kids? It does not appear sane or rational to me to make children wear a mask for 6 hours in a classroom when they know that the minute they step out those doors, those same masks don't matter.

I will again remind people that we will never be at zero risk. And that while the idea of risking one person's life is, of course, horrifying, we take calculated risks every day with our children. We put them in the car (statistically one of the most dangerous things we all do every day), we put them on school buses with no seat belts, we let them jump on trampolines and ride bikes and go snowboarding. At this time, going to school without a mask is much less dangerous than any of these things.

I am writing to make public comments for the March 8th Board of Education meeting, which I am unsure whether I can physically attend.

My name is Barbara Adu and I am a parent and resident of Hamden. I would like the 8 members of the Board of Education to reconsider the mask mandate for Hamden public school children. I previously sent an email to each member on March 1 after hearing the vote results of Feb 28. Since then:

- The CDC has released a COVID-19 Community Level transmission map, and all 8 counties in Connecticut are in the "green zone," or low levels of community transmission.
- 85% of Connecticut public schools are currently mask-optional, including almost all of Hamden's neighboring towns (except New Haven). New Haven recently lifted the mask mandate for indoor spaces (as of March 7).
- Waterbury public schools recently lifted their mask mandate (as of March 7).
- UConn is currently recommending masks in most settings, rather than mandating them.
- Connecticut Office of Early Childhood gave daycares and preschools the okay to move to maskoptional. **Note this is for the age group who cannot get vaccinated.**

Lastly, I would like you to consider the Hamden public school children who *have been* vaccinated, and/or recently infected by covid - both of which scenarios provide immunity/antibodies. In the case of my child, who was vaccinated yet still caught the Omicron variant in January, they have twice the immunity yet have to wear a mask "for show." The other three members in my family attend work and daycare settings which have already lifted the mask mandate. Thus, who is my child protecting by wearing a mask, exactly?



Thank you for your difficult but important decision to continue masking in schools. Until there has been more time to assess how the new CDC guidelines apply to schools, and until there is approval for 2-5 year olds to get vaccinated, and until the vaccination rates of children in our town improve, and until there are significant changes to the OEC, AAP, and QVHD guidelines, we need to continue erring on the side of caution.

Emotionally, we are all ready to be done with Covid. But scientifically, Covid is not done with us. There are still plenty of cases of family infections spread through children in the household. There are still pre-school & pre-K classrooms getting shutdown because of Covid exposures.
