 - ii) Question about homelessness and food insecurity; has not heard about students becoming homeless, but more and more people coming to get food, so struggling more

 - i) Cancelling Finals
 - ii) Re-weighting this year
 - (1) Prior to Co-Vid 19; Pass/Fail (NCAA) Pass would be lowest passing grade; but yesterday Pass would be 2.3 but if lower GPA then would not use it.
 - (2) State all over with this; school thinking about how can best serve kids thinking about keeping numerical grades and having much input from teacher
 - e) Gannon keeping contact: calling all kids/families (20 per night), and her videos
 - f) Will be sending out coaching to help teachers with figuring out the work load to assign

 - i) Prom Postponed; when Lamont moved open date to 5/20, looked at 5 open dates in August
 - h) Graduation try everything not to have virtual graduation; doesn't see in-person happening soon; commissioner of education all decisions are local, but consult Lamont's emergency declaration; consider options including postponement, virtual, how to recognize students
