



## Hamden High School Credit Recovery Summer Program 2020

**Credit Recovery program** is a computer-based online course that uses a **self-taught curriculum**. You are expected to learn the material on your own with support of the teacher of record. Credit Recovery will happen this year in a Distance Learning Format. All students are expected to dedicate approximately three hours a day to completion of their course work. A certified teacher will be available to help you understand the lessons, but will not help during tests on an as needed basis. Teachers will be available "live" Monday through Thursday from 10:00 am-11:00 am and on an as needed basis through Google classroom. These teachers will be monitoring attendance as well as work completion. The program will run from June 15<sup>th</sup> to July 31<sup>st</sup>. Both students and parents must sign the Credit Recovery Contract in order to participate in the program. Administrators reserve the right to dismiss a student from the Credit Recovery program at their discretion.

**Attendance is mandatory.**

### Eligibility

- Credit recovery is available to students who have failed a course or lost credit in a course due to attendance.
- Students may earn up to one full credit in HHS Summer Credit Recovery.
- Courses in math, English, social studies and science will be offered.
- Priority will be given based on anticipated graduation date and to students currently enrolled at Hamden High School.

### Participation Information

- Both students and guardians must agree to the Credit Recovery Contract in order for the student to participate.
- Students are required to take notes during each lesson.
- A progress report will be sent up weekly every Friday.

**Attendance is mandatory.**

Students who make no progress or fail to check into credit recovery classes for more than 3 days will be withdrawn from the credit recovery program.

## Hamden High School Credit Recovery Contract Summer 2018

1. All students must abide by the Acceptable Use Policy they sign during the school year.
2. Attendance is mandatory. Students who make no progress or fail to check into credit recovery classes for more than 3 days will be withdrawn from the credit recovery program.
3. Students must earn a minimum of 60 percent grade average to earn credit for the course.
4. Students may re-take quizzes/tests up to 2 times.
5. Any student caught cheating will have to restart the subject from the beginning. If caught a second time, the student will be removed from the class.
6. Behavioral problems will result in immediate removal from the program.
7. It is recommended for students to work on their coursework for an additional hour each day.
